Wales' commitment to young people leaving care

A guide for corporate parents

The Children's Commissioner for Wales believes that all young people should have an equal chance to be the best they can be as they approach adulthood.

Wales' commitment to young people leaving care should include somewhere safe to live with financial security, an active offer of education, work or training and ongoing social and emotional support.

There are two underpinning pieces of legislation that should drive this work: the UN Convention on the Rights of the Child (UNCRC) and the Well-being of Future Generations (Wales) Act 2015.

UNCRC

All children and young people have rights under the UNCRC to have their needs met (provision), to be safe (protection) and to have a say in decisions that affect them (participation) – all of the things they need to help them fulfil their potential.

Well-being of Future Generations Act

The 5 ways of working are the ways that Local Authorities can show that they are taking their decisions with this principle in mind. Following these 5 ways of working will also make sure that children and young people's fundamental rights to health, education, support and financial assistance under the UNCRC are being upheld and kept in mind by all those who work with children in care and care leavers.

Canllaw i rieni corfforaethol

Mae Comisiynydd Plant Cymru yn credu y dylai pob person ifanc gael cyfle cyfartal i fod y gorau gallan nhw fod wrth dyfu'n oedolion.

Dylai ymrwymiad Cymru i bobl ifanc sy'n gadael gofal gynnwys rhywle diogel i fyw gyda sicrwydd ariannol, cynnig gweithredol ym myd addysg, gwaith neu hyfforddiant, a chefnogaeth gymdeithasol ac emosïynol barhaus.

CCUHP

O dan CCUHP mae gan bob plentyn a pherson ifanc hawliau i gael diwallu eu hanghenion (darpariaeth), i fod yn ddiogel (diogelu) ac i gael lleisio barn ar benderfyniadau sy'n effeithio arnyn nhw (dweud eu dwed) – yr holl bethau maen nhw angen i'w helpu i gyflawni eu potensial.

Deddf Llesiant Cenedlaethau'r Dyfodol

Y 5 ffordd o weithio yw'r dulliau sydd gan Awdurdodau Lleol i ddangos eu bod nhw'n cadw'r egwyddor hon mewn cof wrth wneud penderfyniadau. Bydd dilyn y 5 ffordd yma o weithio hefyd yn sicrhau bod hawliau sylfaenol plant a phobl ifanc i gael iechyd, addysg, cefnogaeth a chymorth ariannol o dan CCUHP yn cael eu cynnal a'u cadw mewn cof gan bawb sy'n gweithio gyda phlant sydd mewn gofal ac ymadawyr gofal.

Long Term -

Ongoing support for all care leavers up to the age of 25 will meet their long-term needs, help them to become independent, to reach their ambitions and improve personal outcomes.

Prevention -

Making sure that young people have the skills they need before living on their own

Integration -

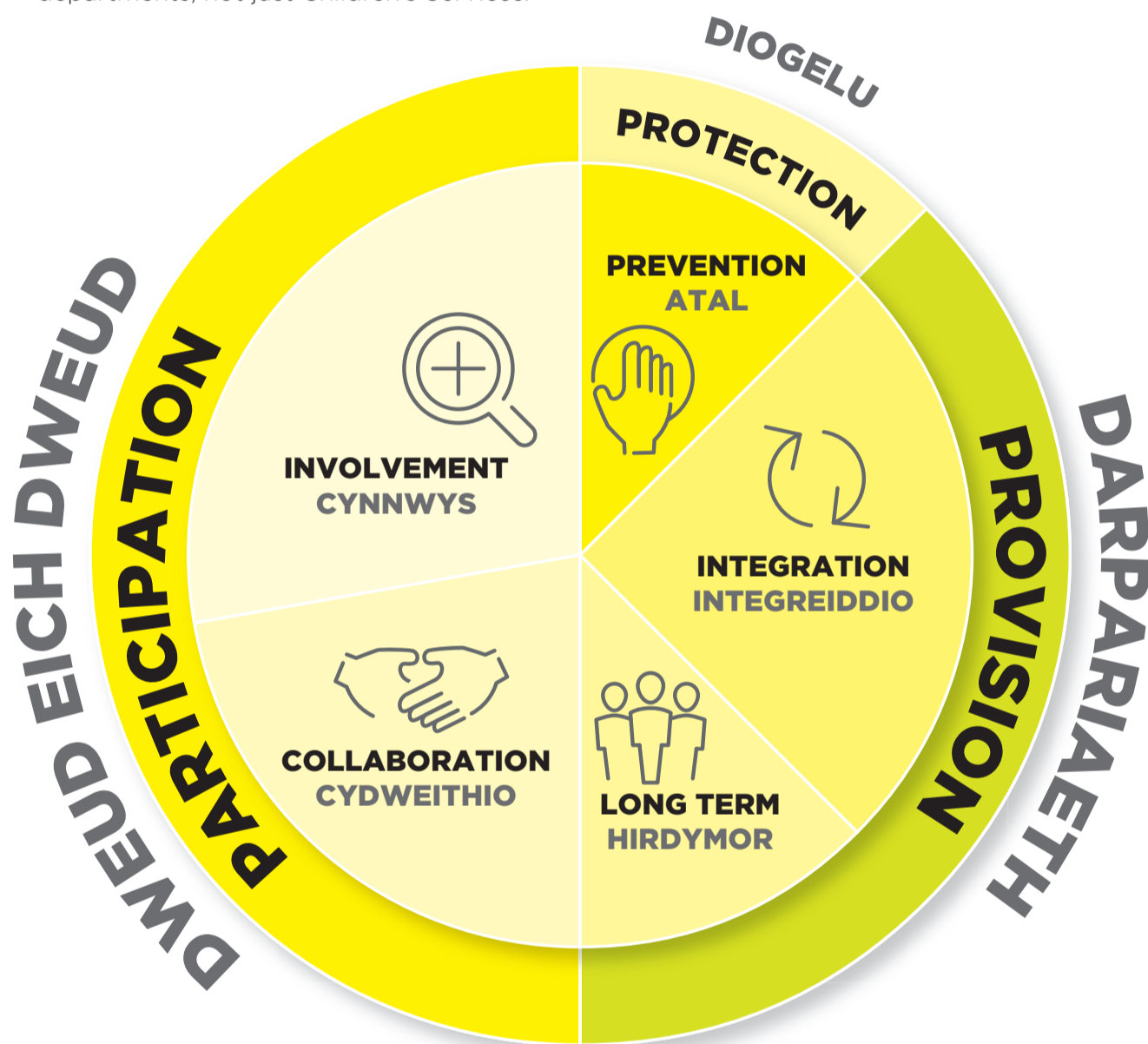
Corporate Parenting is everyone's responsibility in the local authority; the needs of care leavers have to be integrated into planning for service delivery in all departments, not just Children's Services.

Collaboration -

Personal advisers and social workers are an important source of support for young people and need to work closely with them and others to make sure that they have the support they need.

Involvement -

Care leavers' forums are a clear way to directly involve young people in the design and analysis of service delivery and setting priorities for the future.



Tymor Hir -

Cefnogaeth barhaus i bawb sy'n gadael gofal hyd at 25 oed, er mwyn ymateb i'w hanghenion tymor hir, eu helpu nhw i ddod yn fwy annibynnol, i gyflawni eu dyheadau a gwella'u canlyniadau personol.

Ataliaeth -

Sicrhau bod gan bobl ifanc y sgiliau sydd angen cyn byw yn annibynnol.

Integreiddio -

Mae Rhianta Corfforaethol yn gyfrifoldeb i bawb yn yr awdurdod lleol; mae'n rhaid integreiddio anghenion ymadawyr gofal wrth gynllunio ar gyfer darparu gwasanaeth ym mhob adran, nid dim ond y Gwasanaethau Plant.

Cydweithio -

Mae cefnogaeth cynghorwyr personol a gweithwyr gymdeithasol yn bwysig i bobl ifanc a mae'n rhaid iddyn nhw gweithio'n agos gyda phobl ifanc, ac eraill, i wneud yn siwr bod ganddyn nhw y gefnogaeth sydd angen.

Cynnwys -

Mae fforymau ymadawyr gofal yn ffordd glir o gynnwys pobl ifanc yn uniongyrchol wrth ddylunio a dadansoddi'r gwasanaethau sy'n cael eu cyflwyno a phennu blaenoriaethau at y dyfodol.
